

**Professional Teacher Education**

Application period: 2 January to 23 January 2020. Application period ends on 23 January 2020 at 15.00 Finnish time.

## Eligibility requirements in short:

An applicant must have a relevant higher education degree and the required work experience.

*Applicants who seek qualification as vocational subject teachers*

- Bachelor's (or higher) degree and 3 years of professional work experience
- applicants applying with a UAS Bachelor's degree in the field of Social Services and Health (excl. the field of Beauty Care): 5 years of work experience corresponding to the content of the degree
- applicants applying with a Master's degree in the field of Social Services and Health: 3 years of professional work experience (N.B. Bachelor's degree in the field of Social Services and Health completed in a university (as opposed to a UAS) does not grant eligibility to apply for Professional Teacher Education)
- applicants from the field of Dance or Circus: 3 years of relevant studies and 3 years of professional work experience

*Applicants who seek qualification as general subject teachers*

- in most cases a relevant Master's degree; no professional work experience required

*Applicants working as vocational subject teachers and applying without a higher education degree*

- 5 years of professional work experience

No admission points will be granted for the degree and work experience required for eligibility.

1. First preference for admission
2. Teaching experience from vocational education since 1 January 2018, yes
3. Teaching experience from official educational institutions, over 20 months
4. Teaching experience from official educational institutions, over 15–20 months
5. Teaching experience from official educational institutions, over 10–15 months
6. Teaching experience from official educational institutions, over 5–10 months
7. Teaching experience from official educational institutions, over 2–5 months
8. Basic studies in educational sciences, completed
9. Other completed degrees, two degrees
10. Other completed degrees, one degree
11. Further education, 30 cr or more
12. Further education, 26–29 cr
13. Further education, 22–25 cr
14. Further education, 18–21 cr
15. Further education, 14–17 cr
16. Further education, 10–13 cr
17. Further education, 6–9 cr
18. Further education, 2–5 cr

If the applicant selection is not finalized based on the aforementioned criteria, a random computer-generated selection will be employed.
